In 2006 we merged with two other northeast dairy groups to form NDA. Our Association now consists of over 220 member companies including international businesses as well as small, family owned companies, all of whom distribute goods and services to the dairy industry.

The members of the Northeast Dairy Association, Inc. are administered by a Board of Directors elected from the general membership. Director meetings are held three times a year, in addition to the annual meeting. The members are governed by by-laws that provide specific direction and guidelines in compliance with association business law.

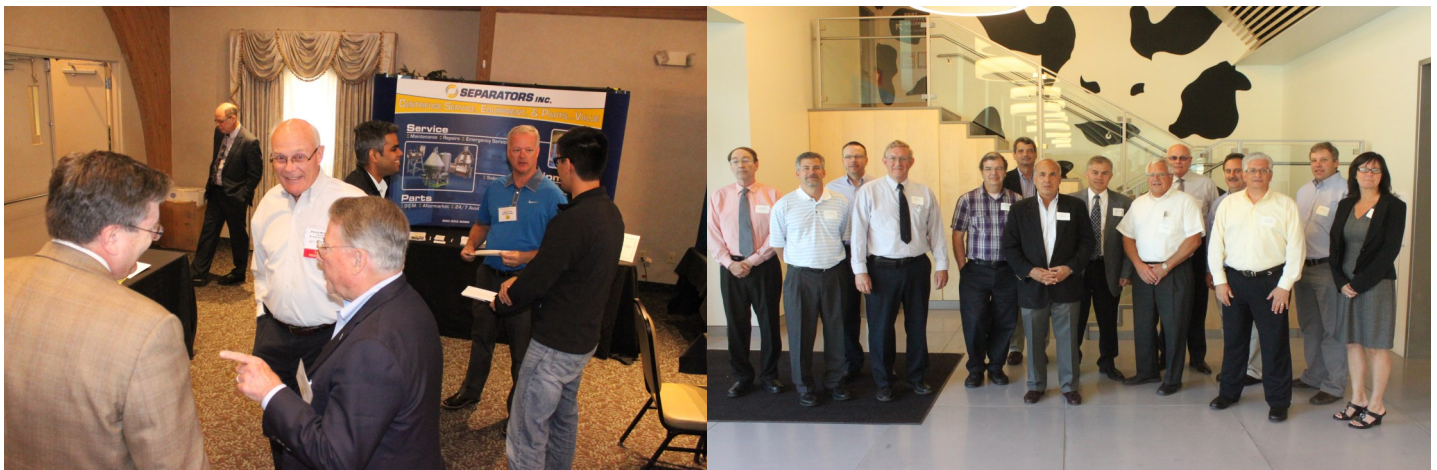
## Membership Dues
